Professional Workspace

The applicant must arrange a suitable office space or commercial location that meets EPR operational standards and service requirements.

Franchise & Renewal Fee

A one-time franchise/setup fee and annual renewal fee shall be applicable as per the policies of EPR.

Compliance with Standards

The centre must maintain professional ethics, quality service standards, operational transparency, and compliance with applicable laws and regulations.

What is an EPR Authorized Partner?

An **Authorized Partner** is an individual or organization already operating in the field of career guidance, education consultancy, employment facilitation, recruitment support, training, or related services who wishes to collaborate with EPR to expand their services and business opportunities.

Through this partnership, existing businesses may strengthen their market presence, increase service offerings, and benefit from EPR's professional support system, branding, and network.

Eligibility Criteria for Authorized Partner

Any existing business or service provider interested in becoming an Authorized Partner must fulfill the following requirements:
