03. The competent authority has the right to Increase / Decrease / Nil the posts at any stage without assigning any reason.
04. **No application form will be accepted By Hand / without form processing fee.**
05. Only shortlisted candidates will be called for interview. Short listing will be done either by written test or by their pre-interview marks or both.
06. Their services will be governed, under the Khyber Pakhtunkhwa Medical & Teaching Institutions Reform ACT 2015 (Amended) from time to time.
07. **If the closing date fixed for the receipt of application form falls on an official holiday, the next working day shall be considered as the closing date.**
08. **An application after the closing time and date shall stand automatically rejected.**
09. In-service candidate should apply through proper channel.
10. Age relaxation will be given as per Govt. of Khyber Pakhtunkhwa rules.
11. In case of selection of civil servant in MTI-B&PSC, he or she will have to resign from the current post of civil servant.
